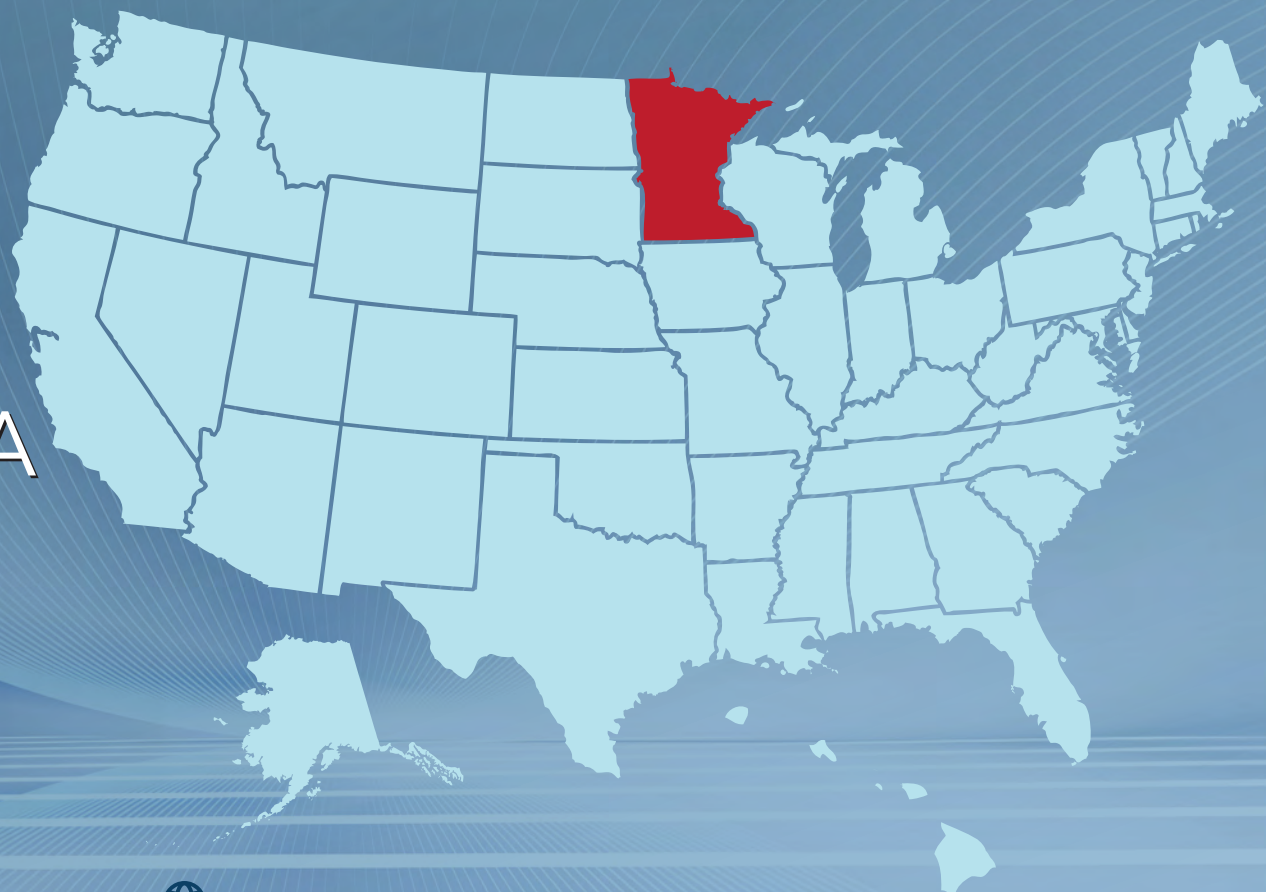

Dear Fellow Conservative,

The American Conservative Union Foundation is proud to present our ratings of the 2018 meeting of the Minnesota State Legislature. Like our *Ratings of Congress*, which date back 47 years, our state ratings are meant to reflect how elected officials view the role of government in an individual's life. We begin with our philosophy i.e., conservatism is the political philosophy that sovereignty resides in the person, and then apply our understanding of government (its essential role is to defend Life, Liberty and Property).

Because our ratings are designed to educate the public about how consistently elected officials adhere to conservatism, we carefully examine the entire docket of legislation introduced in each state every year. We select the most meaningful bills and publish the results after the dust has settled. ACUF state ratings—launched in 2011 with ratings for five states—have become a nationally recognized resource for evaluating over 8,000 elected officials comprising each of America's 99 state legislative chambers.

Each election cycle, citizens choose leaders whose vision for the state most closely matches their own, hoping that candidates' promises will be kept. ACUF's ratings measure whether those promises were fulfilled or forsaken. With nearly a decade of data on state legislators' voting records and average scores for every legislative chamber, citizens in every state can assess how effectively their lawmakers have applied conservative philosophy to the role of government.

We at ACUF believe, as Ronald Reagan once said, that freedom is never more than one generation away from extinction. We hope that by providing this unique tool, these ratings will empower Americans to exercise their right to protect our unique American democracy from tyranny.

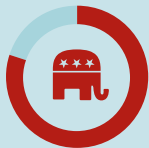
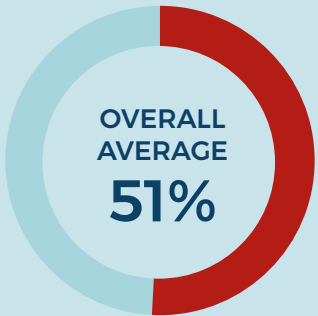

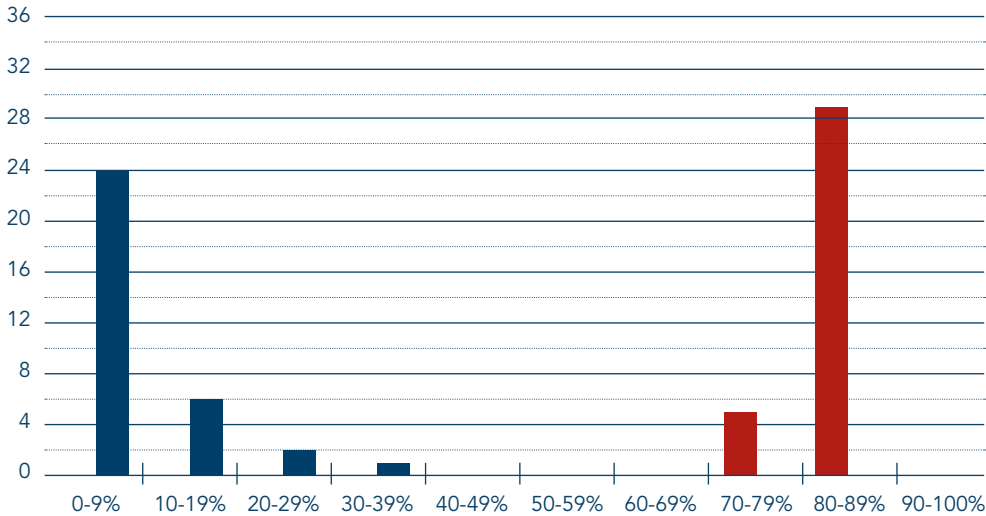

## MINNESOTA SENATE VOTE DESCRIPTIONS

1. **SF 3656 Discriminating against Internet Providers that Don't Abide by "Net-Neutrality."** The Latz (ACUF Lifetime 13%) amendment to the budget bill attempts to punish Internet Service Providers (ISPs) that don't abide by Obama-era "net-neutrality" rules (overturned by Ajit Pai and the FCC) which interfere in the way providers deliver their services and structure their fees. Under the amendment, governmental bodies are prohibited from contracting with or providing funding to ISPs that don't abide by net-neutrality rules. ACU opposes net-neutrality rules and this attempt to drive up taxpayer costs by limiting government contracting options and opposed this amendment. The Senate voted to kill the amendment on April 26, 2018 by a vote of 34-33. (A "Yes" vote supported the ACU position.)
2. **SF 3656 Reducing Government Oversight of State Collective Bargaining Activities.** The Cohen (ACUF Lifetime 8%) amendment to the budget bill eliminates the duty of the state legislative coordinating commission to review and advise on collective bargaining agreements with state employees, including the review of changes to the state's employee insurance program. ACU opposes reducing government oversight, especially over collective bargaining agreements which can have major implications to taxpayers, and opposed this amendment. The Senate failed to pass the amendment on April 26, 2018 by a vote of 33-34.
3. **SF 3656 Requiring Written Permission from Property Owners to Place Hunting Traps.** The Eaton (ACUF Lifetime 8%) amendment to the budget bill prevents an individual from placing a trap or snare on a private parcel of property unless they have written permission from the property owner. ACU Foundation's Center for 21st Century property rights is a leading voice on issues such as this, relating to the strengthening and preservation of real property rights. While ACU has long supported hunting rights, we believe the state needs to appropriately respect landowner property rights, including the fundamental principal that no one can use another's property without their permission, and supported this amendment. The Senate defeated the amendment on April 26, 2018 by a vote of 33-34.
4. **SF 3656 Mandating Railroad Train Crew Sizes.** The Dibble (ACUF Lifetime 8%) amendment to the budget bill forces all railroad trains and locomotives operating in the state to have crews of at least two individuals. ACU opposes this mandate, especially in a time of automation, which drives up the cost of business and creates different rules for trains operating across state lines and opposed this amendment. The Senate defeated the amendment on April 26, 2018 by a vote of 33-33.
5. **SF 3656 Seizing Firearms without Due Process.** The Latz (ACUF Lifetime 13%) amendment to the budget bill permits law enforcement officers to submit an ex parte (i.e., one-sided) petition to a court for the issuance of an "Extreme Risk Prevention Order," which permits the government to seize all firearms held by an individual based on accusations that someone is considered to be a danger to oneself or others simply due to one's possession of a firearm. ACU supports the founders' belief in the Second Amendment, opposes the seizure of firearms without due process and on the basis of unchallenged accusations and opposed this amendment. The Senate defeated a motion to advance the amendment on April 26, 2018 by a vote of 37-29. (A "Yes" vote supported the ACU position.)
6. **SF 3656 Establishing and Funding a New Council to Benefit Select Individuals.** The Isaacson (ACUF Lifetime 9%) amendment to the budget bill requires the establishment of a Council on LGBTQI Minnesotans. Under the amendment, the council is directed to hire an executive director and staff who will work for the implementation of economic, social, legal, and political equality for the LGBTQI community, including working with state agencies to develop business opportunities and promote economic development. ACU believes in equal rights under the law for all, that it is the duty government to ensure all laws are applied equally, and that those who discriminate will face repercussions in the marketplace. ACU opposes this this council which unequally provides benefits to a select class of people and opposed this bill. The Senate defeated the amendment on April 26, 2018 by a vote of 33-34.





7. **SF 3656 Mandating Health Insurance Plans Cover Contraceptives.** The Pappas (ACUF 6%) amendment to the budget bill mandates that all health plans offered in the state (except through faith-based employers) provide full coverage of contraceptives and sterilization procedures, and without any co-pay or deductible. ACU opposes insurance mandates and believes the use of contraceptives is a matter of individual liberty and something for which others should not be forced to pay through higher insurance premiums and taxes and opposed this bill. The Senate defeated the amendment on April 26, 2018 by a vote of 33-33.
8. **SF 3656 Permitting the Collection of Data on Firearm Ownership.** The Klein (ACUF Lifetime 11%) amendment to the budget bill permits the Commissioner of Health to collect data on individuals who lawfully own a firearm or are lawfully able to carry a weapon if the data does not reveal any of the subject's identities and is used for purposes of public health research or epidemiologic investigations. ACU supports the founders' belief in the Second Amendment, opposes invasive government data collections, and opposed this amendment. The Senate defeated a motion to advance the amendment on April 26, 2018 by a vote of 36-29 (A "Yes" vote supported the ACU position).
9. **SF 2849 Providing Abortion Patients the Opportunity to View an Ultrasound.** This bill requires that prior to an abortion, a physician provide the patient with the opportunity to view the results of any ultrasound that was performed. ACU believes abortion is a human tragedy, supports restrictions on the practice and educating patients and supported this bill. The Senate passed the bill on May 1, 2018 by a vote of 37-30 but it was vetoed by the governor.
10. **HF 4385 Eliminating Individual and Corporate Tax Cuts.** The Cohen (ACUF Lifetime 8%) amendment to a tax bill removes a provision that reduces individual and corporate franchise tax rates in the event state revenue collections meet certain levels. ACU supports expanding economic growth through tax cuts and opposed this amendment. The Senate failed to pass the amendment on May 3, 2018 by a vote of 32-34.
11. **HF 4385 Eliminating School Choice Tax Deductions.** The Clausen (ACUF Lifetime 11%) amendment to a tax bill prevents an income tax exemption for contributions to 529 savings accounts for purpose of K-12 educational expenses. The amendment is in response to a provision championed by Ted Cruz (ACUF Lifetime 99%) within the federal Tax Cut and Jobs Act which expanded school choice by allowing 529 savings accounts to be used for elementary and secondary education. ACU supports expanding educational opportunities through school choice and opposed this amendment. The Senate failed to pass the amendment on May 3, 2018 by a vote of 32-34.
12. **HF 4385 Expanding the Earned Income Tax Credit.** The Rest (ACUF Lifetime 15%) amendment to a tax bill expands eligibility and subsidies under the state's Earned Income Tax Credit (EITC). Under the amendment, certain individuals with adjusted gross incomes of up to \$26,360 (previously \$25,180) are eligible for the EITC, and the maximum subsidy an individual can receive is increased to 15.78 percent of earned income (previously 11 percent). ACU opposes the further expansion of the EITC which redistributes the taxes paid by one group of taxpayers to another group of individuals and opposed this amendment. The Senate failed to pass the amendment on May 3, 2018 by a vote of 32-34.
13. **HF 3280 Eliminating Burdensome Regulations of Wild Rice.** This bill eliminates a regulation that limits discharges of sulfates into waters where wild rice grows to 10 milligrams per liter. The standard is currently unenforced and considered by municipalities to be technically and economically unfeasible to be in compliance. The bill instead establishes a working group to prepare recommendations to protect the state's wild rice. ACU supports reforming unenforced and ineffective regulations that harm economic growth and supported this bill. The Senate passed the bill on May 7, 2018 by a vote of 38-28.
14. **SF 3245 Expanding a Renewable Energy Program that Places Taxpayer Funds at Risk.** This bill reauthorizes and expands the government-run renewable energy financing program known as PACE (Property Assessed Clean Energy). The program provides up to 20 years of financing for renewable energy and energy efficient systems in homes through an additional property tax assessment. ACU does not believe it is the proper role of government to provide financing services and opposes this program which places taxpayers at risk in the event of a default and opposed this bill. The Senate passed the bill on May 7, 2018 by a vote of 65-1.



**15. HF 947 Reducing Personal Income and Corporate Tax Rates (Attempt No. 1).** This bill changes the state's tax code to help conform it to the federal Tax Cuts and Job Act, including providing a net personal income and corporate tax cut of over \$565 per a biennium. Specifically, the 7.05 percent and 5.35 percent personal income tax brackets are reduced to 6.85 percent and 5.25 percent, respectively, and the corporate tax rate is reduced from 9.8 percent to 9.65 percent, and reduced again in 2020 to 9.1 percent. Reducing tax burdens increases economic growth, which increases family prosperity, as illustrated by the ACU Foundation's Family Prosperity Index. ACU supports pro-growth tax reform and supported this bill. The Senate passed the bill on May 14, 2018 by a vote of 34-33 but it was vetoed by the governor.

---

**16. HF 2940 Requiring Legislative Approval of Fee Hikes by the Pollution Control Agency.** This bill helps protect the authority of the legislative branch to levy taxes and fees by preventing the Pollution Control Agency from increasing fees for certain water related activities without approval by the legislature. ACU supports this check on unelected government bureaucrats and restoration of taxing authority to the legislative branch and supported this bill as a step in the right direction. The Senate passed the bill on May 14, 2018 by a vote of 40-27 but the bill was later vetoed by the governor.

---

**17. HF 3759 Bypassing Unnecessary Regulatory Requirements to Construct a Crude Oil Pipeline.** This bill fast tracks the construction approval process of the Enbridge Line 3 crude oil pipeline by requiring the state's public utilities commission to issue a "certificate of need." The state approval process for the interstate pipeline, which stretches over 1,000 miles, began in 2015 and has already passed environmental impact standards. ACU supports reducing unnecessary regulatory burdens on a project that is expected to drastically expand economic growth and drive down fuel costs for all Americans and supported this bill. The Senate passed the bill on May 16, 2018 by a vote of 35-32 but it was vetoed by the governor.

---

**18. HF 4385 Reducing Personal Income and Corporate Tax Rates (Attempt No. 2).** This bill is the legislature's second attempt to change the state's tax code—after the governor vetoed HF 4385—to help conform it to the federal Tax Cuts and Job Act, including providing a net personal income and corporate tax cut of over \$565 per a biennium. Specifically, the 7.05 percent and 5.35 percent personal income tax brackets are reduced to 6.85 percent and 5.25 percent, respectively, and the corporate tax rate is reduced from 9.8 percent to 9.65 percent, and reduced again in 2020 to 9.1 percent. Reducing tax burdens increases economic growth, which increases family prosperity, as illustrated by the ACU Foundation's Family Prosperity Index. ACU supports pro-growth tax reform and supported this bill. The Senate passed the bill on May 16, 2018 by a vote of 34-33 but it was vetoed by the governor.

---

**19. SF 3367 Mandating Sex Trafficking Training for All Hotel Employees.** This bill forces all hotels and motels operating in the state to bear the cost of new sex trafficking training for employees within 90 days of their hiring. While ACU is sensitive to the state's intention to combat issues such as human trafficking, we oppose this overly burdensome government interference in the marketplace that harms law-abiding businesses and drives up consumer costs. Therefore, ACU opposed this bill. The Senate passed the bill on May 16, 2018 by a vote of 60-1.

---

**20. HF 740 Interfering in Motor Vehicle Franchise Contracts.** This bill triggers state involvement in negotiations between automobile dealers and manufacturers in order to help dealers charge higher prices. ACU believes manufacturers and dealers should be free to negotiate their own private contracts and opposes this government interference which will result in higher consumer costs and weaker consumer warranties and opposed this bill. The Senate passed the bill on May 20, 2018 by a vote of 67-0.

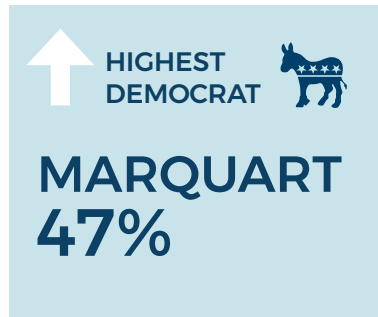
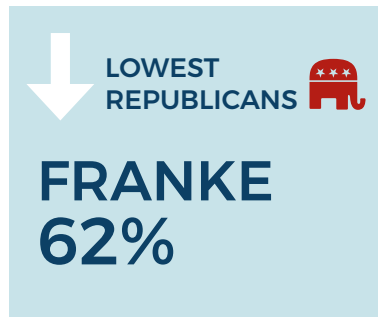
### MINNESOTA HOUSE CONSERVATIVE RATINGS



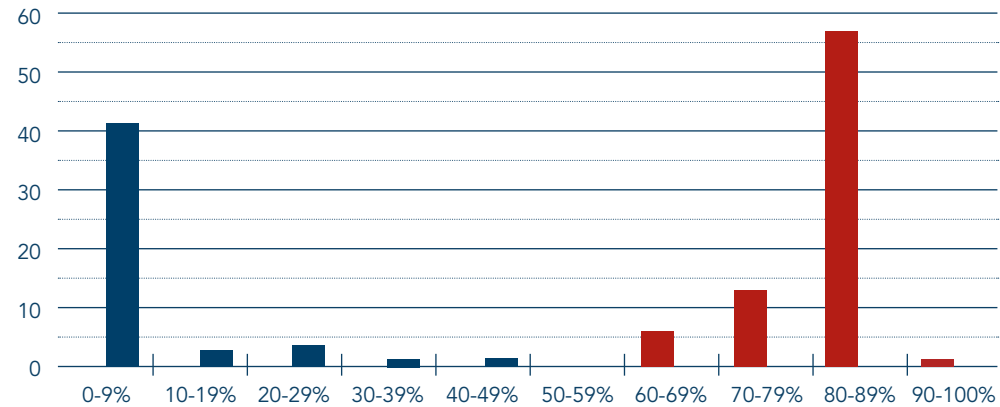

## MINNESOTA HOUSE VOTE DESCRIPTIONS

1. **HF 2887 Allowing the Sale of Nitrogen Fertilizer.** This bill prohibits the Minnesota Department of Agriculture from banning the sale of nitrogen fertilizer. ACU supports the ability of people to cultivate their land using reasonable products such as nitrogen fertilizer and supported this bill. The House passed the bill on April 16, 2018 by a vote of 69-56.

---

2. **SF 3306 Adding Burdensome Regulations to Campaign Finance Laws.** The Nelson (ACUF Lifetime 12%) amendment to a campaign finance bill would require lobbying firms to produce 10 years' worth of records detailing any payments their lobbyists have received from any business or organization. ACU opposes this retroactive mandate that places an undue burden on firms (especially those firms that may no longer retain such records) and opposed this amendment. The House defeated the amendment on May 2, 2018 by a vote of 44-78.

---

3. **SF 3656 Preventing Employers from Seeking Prospective Employee Wage History.** The Moran (ACUF Lifetime 8%) amendment prevents all employers from seeking the wage history of a prospective employee or requiring that a prospective employee's prior wage history meet certain criteria. ACU opposes this government interference in the private marketplace and believes it is a reasonable hiring practice for employers to seek past wage history, especially when it is required in the federal hiring process, and opposed this amendment. The House defeated the amendment on May 3, 2018 by a vote of 52-73.

---

4. **SF 3656 Establishing a Solar Energy Grant Program for School Districts.** The Wagenius (ACUF Lifetime 4%) amendment to the budget bill establishes a new grant program under the Department of Commerce to award grants to school districts so they can pursue "energy conservation improvements," including solar energy systems. ACU supports all forms of energy and opposes programs that drive up taxpayer costs by failing to consider cost effectiveness and opposed this amendment. The House defeated the amendment on May 3, 2018 by a vote of 45-80.

---

5. **HF 3280 Eliminating Burdensome Regulations of Wild Rice.** This bill eliminates a regulation that limits discharges of sulfates into waters where wild rice grows to 10 milligrams per liter. The standard is currently unenforced and considered by municipalities to be technically and economically unfeasible to be in compliance. The bill instead establishes a working group to prepare recommendations to protect the state's wild rice. ACU supports reforming unenforced and ineffective regulations that harm economic growth and supported this bill. The House passed the bill on May 7, 2018 by a vote of 79-48.

---

6. **HF 2940 Requiring Legislative Approval of Fee Hikes by the Pollution Control Agency.** This bill helps protect the authority of the legislative branch to levy taxes and fees by preventing the Pollution Control Agency from increasing fees for certain water related activities without approval by the legislature. ACU supports this check on unelected government bureaucrats and restoration of taxing authority to the legislative branch and supported this bill as a step in the right direction. The House passed the bill on May 8, 2018 by a vote of 77-41 but the bill was later vetoed by the governor.

---

7. **SF 2849 Providing Abortion Patients the Opportunity to View an Ultrasound.** This bill requires that prior to an abortion, a physician provide the patient with the opportunity to view the results of any ultrasound that was performed. ACU believes abortion is a human tragedy, supports restrictions on the practice and educating patients and supported this bill. The House passed the bill on May 10, 2018 by a vote of 79-48 but it was vetoed by the governor.

---

8. **SF 3245 Expanding a Renewable Energy Program that Places Taxpayer Funds at Risk.** This bill reauthorizes and expands the government-run renewable energy financing program known as PACE (Property Assessed Clean Energy). The program provides up to 20 years of financing for renewable energy and energy efficient systems in homes through an additional property tax assessment. ACU does not believe it is the proper role of government to provide financing services and opposes this program which places taxpayers at risk in the event of a default and opposed this bill. The House passed the bill on May 14, 2018 by a vote of 123-0.

---



- 
9. **HF 4385 Reducing Personal Income and Corporate Tax Rates (Attempt No. 1).** This bill changes the state's tax code to help conform it to the federal Tax Cuts and Job Act, including providing a net personal income and corporate tax cut of over \$565 per a biennium. Specifically, the 7.05 percent and 5.35 percent personal income tax brackets are reduced to 6.85 percent and 5.25 percent, respectively, and the corporate tax rate is reduced from 9.8 percent to 9.65 percent, and reduced again in 2020 to 9.1 percent. Reducing tax burdens increases economic growth, which increases family prosperity, as illustrated by the ACU Foundation's Family Prosperity Index. ACU supports pro-growth tax reform and supported this bill. The House passed the bill on May 15, 2018 by a vote of 78-50 but it was vetoed by the governor.
- 
10. **SF 3367 Mandating Sex Trafficking Training for All Hotel Employees.** This bill forces all hotels and motels operating in the state to bear the cost of new sex trafficking training for employees within 90 days of their hiring. While ACU is sensitive to the state's intention to combat issues such as human trafficking, we oppose this overly burdensome government interference in the marketplace that harms law-abiding businesses and drives up consumer costs. Therefore, ACU opposed this bill. The House passed the bill on May 15, 2018 by a vote of 125-0.
- 
11. **HF 1180 Banning the Use of Cellphones While Driving.** This bill bans the usage of a handheld cellphone while operating a motor vehicle including actions such as texting and web-browsing. ACU opposes penalizing motorists for the responsible use of cellphones absent any other driving infractions and opposed this bill. The House failed to advance the bill on May 16, 2018 by a vote of 53-74.
- 
12. **HF 3674 Legislative Oversight of Collective Bargaining.** This bill requires detailed information from the state Office of Management and Budget to be included in a collective bargaining agreement submitted to the legislative Subcommittee on Employee Relations, including a breakdown of costs, how costs would fit into the budget of each agency, and contingency plans if revenue proves insufficient to cover costs. ACU supports more legislative oversight of government collective bargaining and supported this bill. The House passed the bill on May 16, 2018 by a vote of 74-52.
- 
13. **HF 3759 Bypassing Unnecessary Regulatory Requirements to Construct a Crude Oil Pipeline.** This bill fast tracks the construction approval process of the Enbridge Line 3 crude oil pipeline by requiring the state's public utilities commission to issue a "certificate of need." The state approval process for the interstate pipeline, which stretches over 1,000 miles, began in 2015 and has already passed environmental impact standards. ACU supports reducing unnecessary regulatory burdens on a project that is expected to drastically expand economic growth and drive down fuel costs for all Americans and supported this bill. The House passed the bill on May 17, 2018 by a vote of 74-53 but it was vetoed by the governor.
- 
14. **HF 740 Interfering in Motor Vehicle Franchise Contracts.** This bill triggers state involvement in negotiations between automobile dealers and manufacturers in order to help dealers charge higher prices. ACU believes manufacturers and dealers should be free to negotiate their own private contracts and opposes this government interference which will result in higher consumer costs and weaker consumer warranties and opposed this bill. The House passed the bill on May 20, 2018 by a vote of 126-1.
- 
15. **HF 947 Reducing Personal Income and Corporate Tax Rates (Attempt No. 2).** This bill is the legislature's second attempt to change the state's tax code—after the governor vetoed HF 4385—to help conform it to the federal Tax Cuts and Job Act, including providing a net personal income and corporate tax cut of over \$565 per a biennium. Specifically, the 7.05 percent and 5.35 percent personal income tax brackets are reduced to 6.85 percent and 5.25 percent, respectively, and the corporate tax rate is reduced from 9.8 percent to 9.65 percent, and reduced again in 2020 to 9.1 percent. Reducing tax burdens increases economic growth, which increases family prosperity, as illustrated by the ACU Foundation's Family Prosperity Index. ACU supports pro-growth tax reform and supported this bill. The House passed the bill on May 20, 2018 by a vote of 85-42 but it was vetoed by the governor.
